INFORMATION ON THE PROCESSING OF PERSONAL DATA

- 1. The Administrator (Controller) of your personal data is the University of Lodz, with its registered office at ul. Narutowicza 68, 90-136 Łódź;
- 2. Contact to the Data Protection Officer of the University of Lodz:

- 3. Personal data will be processed for the following purposes:
 - 1) registration of you at the Support and Accessibility Centre of the University of Lodz;
 - communication with you on matters related to education and broadly understood activity in the academic environment and to activities in the field of psychological support, developing skills useful in studying and addiction prevention conducted by the Support and Accessibility Centre of the University of Lodz;
- 4. Personal data will be processed in compliance with the provisions of:
 - Article 6(1)(e) of GDPR in connection with Article 2 and Article 11 of the Act of 20 July 2018 Law on Higher Education and Science (as it is necessary to perform a task carried out in the public interest or as part of exercising public authority entrusted to the Administrator (Controller) in connection with the mission of the higher education system and science in the field of education, research activity, shaping civic attitudes, as well as participation in social development and the creation of economy based on innovations);
 - Article 6(1)(b) of GDPR (processing is necessary for the performance of a contract the party of which is the data subject or to take actions upon the request of the data subject prior to entering into a contract);
 - Article 6(1)(c) of GDPR (in connection with the requirements of the law, in particular the Convention on the Rights of Persons with Disabilities of 13 December 2006).
 (Dz.U. Journal of Laws of 2012, item 1169) and acts of internal law in force at the University of Lodz);
 - Article 6(1)(f) of GDPR (in connection with the legitimate interest of the Administrator (Controller), which is the right to establish, investigate and defend against claims).
 - Article 6(1)(a) of GDPR (based on your consent to the processing of personal data in the case of consent to the use of contact details);
 - Article 9(2)(a) of GDPR (based on your consent to the processing of particular categories of personal data).
- 5. In the situation when the processing of personal data takes place on the basis of your consent, you have the right to withdraw your consent at any time without affecting the lawful processing that was carried out before the consent was withdrawn;
- 6. Personal data will be kept for the period necessary to achieve the purpose referred to in point 3, but no longer than for a period of 5 years from the end of studies. In situations provided for in law, personal data may also be processed in the period

necessary to establish and pursue any claims. If you consent to the use of contact details or specific data, this personal data will be stored until you withdraw your consent;

- 7. Your personal data may be made available to other authorized entities on the basis of relevant legal regulations and relevant agreements concluded with the University;
- 8. In connection with the processing of your personal data, you have the right to:
 - 1) access to your personal data,
 - 2) rectify, delete or limit the processing,
 - 3) object to data processing if applicable,
 - 4) transfer personal data under the conditions specified in law,
 - 5) lodge an complaint to the supervisory authority, i.e. to the President of the Personal Data Protection Office with its seat in Warsaw, ul. Stawki 2.
- 9. Providing your personal data is voluntary, but necessary to achieve the purpose referred to in point 3.

Your personal data is processed pursuant to Article 6(1)(a) and (b), (c), (e), (f) and Article 9(2)(a) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing the Directive 95/46/EC (General Data Protection Regulation; Dz.
